We would like to notes/results of these tests which were conducted according to their records I am not asking if they did something that was required or not required, they publicly disclosed a test occurred we would like the results of those tests with enough information to discern what system, its component parts up-to and including the SOFTWARE version used in those tests, the company who performed them and the software version of the voting system of these tests and those that were used on November 3, 2020.

- We only have the results of these tests. The test results are held off-site. We will provide a cost
 estimate for retrieving and returning the items to storage, and compiling the documents. We
 will work towards getting you the cost estimate by next week and will advise if additional time
 is needed to complete the cost estimate;
- No notes exist. We only have the test results per above bullet point;
- Employees performed the tests under the supervision of the Presiding Judge; and
- ES&S software version 6.1.1.0 was utilized on November 3, 2020.
- 2. According to the contract with ES&S the equipment was tested by the secretary of state prior to our the contract being signed and Travis County used those results as their proof that these machines were okay to use. I won\uld like a copy of the results that the SOS did, that Travis County used to approve these systems originally. Since they used these tests the results should be on file with Travis County.
 - Once a system gets certification from the Secretary of State (SOS) it's available for use in the entire state of Texas; and
